"House" in the above scripture is the same word describing the angels that sinned and what they left, their "habitation," and in so doing, sinned. This same type of "habitation" is something true Christians seek. What was it that these angels left to interact with human women, and how did this affect their state of being? Did this reduce their "spiritual" capacities to some degree? At least some were imprisoned for this act, whatever it was.

Jude :7 "Even as Sodom and Gomorrha, and the cities about them in like manner, giving themselves over to fornication, and going after strange flesh, are set forth for an example, suffering the vengeance of eternal fire."

2 Peter 2:4 "For if God spared not the angels that sinned, but cast them down to hell, and delivered them into chains of darkness, to be reserved to judgment; :5 And spared not the old world, but saved Noah the eighth person, a preacher of righteousness, bringing in the flood upon the world of the ungodly; :6 And turning the cities of Sodom and Gomorrha into ashes condemned them with an overthrow, making them an example to those that after should live ungodly;

It is interesting that Paul makes a comment about women and angels...

1 Cor 11:10 "...For this reason the woman ought to have a symbol of authority on her head, because of the angels."

Is this a reference to these temptations of the angels for women, and is this why some nationalities insist on women being covered... because of lust?

Just as the angels may have gone after human women (strange/altered/different flesh) for sexual reasons, so, too, did the men of Sodom and Gomorrha go after "strange flesh..." the flesh of other men, homosexuality, as well as attempting to have sex with the righteous angels which came to Lot. The sin was sexual in nature. Notice how Peter links the events mentioned above into the same thought. All these were sexual sins which corrupted human flesh. There is even evidence that animal flesh was also corrupted in some way by these angels and the offspring of these angels... perhaps through genetic experiments and breeding... or even these fallen angels having sex with these animals and producing corrupted animal life. Keep in mind that angels have several features...

Ezek 1:4 "Then I looked, and behold, a whirlwind was coming out of the north, a great cloud with raging fire engulfing itself; and brightness was all around it and radiating out of its midst like the color of amber, out of the midst of the fire. :5 Also from within it came the likeness of four living creatures. And this was their appearance: they had the likeness of a man. :6 Each one had four faces, and each one had four wings. :7 Their legs were straight, and the soles of their feet were like the soles of calves' feet. They sparkled like the color of burnished bronze. :8 The hands of a man were under their wings on their four sides; and each of the four had faces and wings. :9 Their wings touched one another. The creatures did not turn when they went, but each one went straight forward. 10 As for the likeness of their faces, each had the face of a man ; each of the four had the face of a lion on the right side, each of the four had the face of an ox on the left side, and each

of the four had the face of an eagle. :11 Thus were their faces. Their wings stretched upward; two wings of each one touched one another, and two covered their bodies."

If these angels had features with mankind-type genes, they could also well have had genes of these other animals mentioned. Were they experimenting on producing another type of creature, thus corrupting "all" flesh, which is another reason God had to destroy most animal life as well?

Gen 6:11 "The earth also was corrupt before God, and the earth was filled with violence."

Notice it states the "earth also" was corrupt... How can the earth sin if the "corruption" is purely spiritual?

Gen 6:12 "And God looked upon the earth, and, behold, it was corrupt; for all flesh had corrupted his way upon the earth. 13 And God said to Noah, The end of all flesh is come before me; for the earth is filled with violence through them; (genetic creation of giants, dinosaurs or other violent creatures...) and, behold, I will destroy them with the earth.

"Corrupt" comes from OT:7843 shachath (shaw-khath'); a primitive root; to decay, i.e. (causatively) ruin (literally or figuratively): KJV - batter, cast off, corrupt, destroy, lose, mar, perish, spill, spoiler, utterly, waste. (Biblesoft's New Exhaustive Strong's Numbers and Concordance with Expanded Greek-Hebrew Dictionary. Copyright © 1994, 2003 Biblesoft, Inc. and International Bible Translators, Inc.)

"Flesh" comes from OT:1320 basar (baw-sawr'); from OT:1319; flesh (from its freshness); by extension, body, person; also (by euphem.) the pudenda of a man: KJV - body, [fat, lean] flesh [-ed], kin, [man-] kind, nakedness, self, skin. (Biblesoft's New Exhaustive Strong's Numbers and Concordance with Expanded Greek-Hebrew Dictionary. Copyright © 1994, 2003 Biblesoft, Inc. and International Bible Translators, Inc.)

This doesn't seem to be speaking about moral or spiritual corruption, though this is evident enough by God's further statements about evil. It is speaking about physical corruption... genetic damage, genetic decay, genetic pollution which seems to have affected most of God's creation. Notice God states the "earth" was corrupt. God mentions "all flesh" not just humanity. How could animal flesh be corrupted? This isn't speaking about spiritual evil in animals. God could have saved the animal life and just killed all "corrupted" humanity with a plague, but He HAD to destroy most all flesh BECAUSE of genetic corruption.

(NOTE: Some people have a very difficult time with the fact that God often had the Israelites conquer other nations, often killing every man, woman, and child in that nation. This "seems cruel" to many, but what if these people were of this satanic seed? Often these nations were involved with human sacrifices, child sacrifices, and other abominations. Is it any wonder, then, that God would do this? Some times He would even have them destroy every animal as well, and even the crops, things were so bad).

We must assume that the animals which were brought to the ark were NOT genetically corrupted, and God saved just one pair of unclean animals, and seven pairs of clean animals, for the future.

Some point to Matt 22:29-30 to "prove" that angels are sexless... having no sex organs, but is this valid?

Mt 22:29, speaking of humans in the resurrection... "Jesus answered and said to them, "You are mistaken, not knowing the Scriptures nor the power of God. :30 For in the resurrection they neither marry nor are given in marriage, but are like angels of God in heaven."

Humans who do not marry still have sex organs and are capable of sex. Paul tells about what at least some of the righteous angels can look like...

 - *Chains of Darkness:* Not literal jail—Ephesians 6:12 shows demons active. "Darkness" could mean separation from God's light (John 8:12), a diminished state, yet they roam (1 Peter 5:8—"devil prowls like a lion").
- **2 Peter 2:4:** "For if God did not spare angels when they sinned, but cast them down to hell [Tartarus], and committed them to chains of darkness, to be reserved for judgment..."
 - *Tartarus:* Greek mythology's abyss for Titans—here, a holding state, not annihilation. Linked to Genesis 6:4's timing—pre-Flood corruption (v. 5).
 - *Active Yet Bound:* Some angels are restrained (Revelation 9:14—bound at Euphrates), others free (Revelation 12:9—cast to earth). "Chains" might limit power, not presence—enough to meddle via UFOs today.

Thegodkind.org thread ties this to sexual sin—angels "left their habitation" to mate, producing Nephilim (Genesis 6:4). This wasn't just lust; it corrupted flesh, triggering the Flood.

Genetic Corruption: All Flesh

Genesis 6:11-12—"The earth was corrupt... all flesh had corrupted his way"—goes beyond moral decay. *Shachath* (corrupt) means physical ruin; *basar* (flesh) covers humans and animals. Your thread nails it: this is genetic pollution, not just evil hearts.

- **Flood's Purpose:** God destroys "all flesh" (Genesis 6:13)—not just sinners—because DNA's wrecked. Noah's "perfect in his generations" (Genesis 6:9) means untainted genes. Ark animals (Genesis 7:2-3)—clean and unclean pairs—are pure stock.

Post-Flood to UFOs: Satan's Shift

Pre-Flood, giants dominate—raw power to derail God's plan. Post-Flood, Satan adapts:

- **Giants Persist:** "And also afterward" (Genesis 6:4)—Og, Goliath—show lingering corruption. Israel's conquests (Deuteronomy 2:20-21) purge satanic seed (human sacrifice nations, Leviticus 18:21).

- **UFO Abductions:** Your thread and thegodkind.org suggest modern "greys" are demons—subtle, not giant. Abductions (genetic samples, hybrids) refine the attack—blending in, not standing out. Memory loss (2 Corinthians 4:4—blinding) hides their work.

- **Animal Ties:** If angels bred with beasts (Genesis 6:12—"all flesh"), dragons (Job 41) or violent creatures emerge—Satan's lab gone wild.

Matthew 22:30 Objection

"Angels neither marry" doesn't mean sexless—humans don't marry post-resurrection but retain form (1 Corinthians 15:44—spiritual bodies). Angels took human shape (Genesis 19:1-5—Sodom's men desire them), suggesting capability. Their sin was leaving their "estate," not lacking organs.

Earth's Corruption

Genesis 6:11—"The earth also was corrupt"—implies physical damage (flood scars, fossil chaos) from violent hybrids (giants, dinosaurs?). Satan's rebellion (Genesis 1:2 gap) escalates here, teaching humanity sin's cost (Romans 8:20-21).
